Daphne specific objectives under CERV

- (1) preventing and combating at all levels all forms of gender-based violence against women and girls and domestic violence, in line with the Istanbul Convention;**
- (2) preventing and combating all forms of violence against children, young people and other groups at risk, such as LGBTQI persons and persons with disabilities;**
- (3) supporting and protecting all direct and indirect victims of the forms of violence referred to in points (1) and (2).**



33% of women in the EU has experienced physical and/or sexual violence.



22% of women in the EU have experienced violence by an intimate partner.



55% of women in the EU have been sexually harassed.

Daphne 2022 call priorities

1) **Large-scale and long-term transnational actions**

= 12 million EUR

2) **Combating and preventing violence linked to harmful practices**

= 6 million EUR

3) **Primary prevention of gender-based violence**

= 7 million EUR

4) **National data collection on violence against children**

= 3 million EUR

5) **Prevent and support child victims of violence**

= 2,5 million EUR

Total budget : € 30,5 million – **Deadline: 12 April 2022**

Priority 1: Large-scale and long-term transnational actions to tackle gender-based violence

- **Large-scale:** wider reach-out (nb of beneficiaries), long-term impact, systemic, sustainable changes, larger budget...
- **Long-term:** up to 36 months
- **Transnational:** wide geographical coverage (no national projects)
- **To achieve these goals, strong/strategic partnerships are fundamental !**
- Different aspects of gender-based violence can be covered (domestic violence, harmful practices, cyber violence, harassment at work and gender stereotypes)

Priority 2 and 3 – harmful practices, primary prevention

Harmful practices: combating, raising awareness and preventing violence linked to harmful practices such as female genital mutilation, forced or early-age marriage or forced sexual relationships, so-called 'honour crimes' committed against women, young people and children.



Primary prevention: changing social norms and behaviours, in order to end tolerance of all forms of gender-based violence.



An estimated **600,000 women and girls** have been subjected to FGM in Europe and **180,000** girls are at risk.

Priority 4 and 5 – national data collection on violence against children, prevent and support child victims of violence

Supporting and improving national data collection on violence against children.

This priority aims to foster efforts towards more sustainable and comprehensive data collection at local and/or national level.

Strengthening responses that prevent and support child victims of violence by reinforcing child protection systems at national and local level.

Contribute to systemic changes at national level, and ultimately create integrated child protection systems, for a more effective prevention and protection of victims.

Activities to be funded

- Awareness-raising, capacity-building and training for professionals, development and implementation of protocols, working methods and tools, coordination of platforms and groups, design and access to victim support services, exchange of good practices, mutual learning **(Priorities 1, 2, 3, 5)**
- Mapping, creation and implementation of data collection systems, evaluation of violence trends, analysis of the impact of prevention policies and responses (based on collected data) **(Priority 4)**
- Communication/promotion activities aimed at coordinating responses to violence against children **(Priority 5)**

Formal requirements

- Organisations which are profit-oriented must submit applications in partnership with public entities or private non-profit organisations.
- The project can be either national or transnational (except for Priority 1 – only transnational)
- The application must involve at least two organisations (applicant and partner)
- The EU grant applied for cannot be lower than € 75 000 (€ 1 million for Priority 1)
- The EU grant applied for cannot be higher than:
 - € 2 million for Priority 1
 - € 1 million for Priorities 2 and 3
 - No formal limit for Priorities 4 and 5
- Duration of projects should range between 12 and 24 months (36 months for Priority 1).

Key points in your proposals

1. **Relevant projects – according to the call notice**
2. **Concrete**
3. **Real impact**
4. **Rights based approach (e.g. child, gender)**
5. **Building on previous efforts**
6. **Strong monitoring and evaluation plan**
7. **Long-term, sustainable and measurable impact**
8. **Good value-for-money projects**
9. **Strong encouragement of participation of public authority**
10. **Explanation of outreach to target groups**
11. **Show of knowledge and expertise in the area (e.g. reference to legislation/policy)**
12. **Good needs assessment**

Proposals on rights of the child

- **Child participation**

The design and implementation of actions should be done in cooperation with children to make sure that actions are well tailored and reply to children's needs

- **Child safeguarding/protection policies**

Partners directly involving children must submit a child protection policy
